1. Idarado has filed and recorded a certain plat entitled "Amended and Restated Idarado Project Tract Map" ("Amended Map") in the Office of the San Miguel County Clerk and Recorder ("Official Records") on July 18, 2003, in Reception No. 255734, Plat Book 1, Pages 116-117. The Amended Map terminated, replaced and superseded in its entirety any and all prior established lots, parcels and tracts established on that certain plat entitled "Idarado Legacy Project Tract Map" ("Original Plat") recorded in the Official Records on November 7, 2001, in Plat Book 1, Page 290 and any amendments thereto and any other plats purporting to establish lots, parcels and tracts for portions of the property upon which the Tracts are established by the Amended Map.

2. Idarado is the owner of all of the lands shown upon and included in the Tracts depicted on the Amended Map. Idarado caused the Amended Map to be recorded for the purpose of establishing each of those certain lots, tracts and parcels ("Tracts") shown hereon and such other purposes stated in the Amended Map including Tract E, Tract F and Tract G. 4. No other amendments or modifications to the other Tracts or to the Amended Map are contemplated or intended to be made by the recording of this First Amendment to Amended Map and such Tracts shall continue to exist and the Amended Map shall otherwise remain in full force and effect.

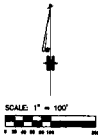
